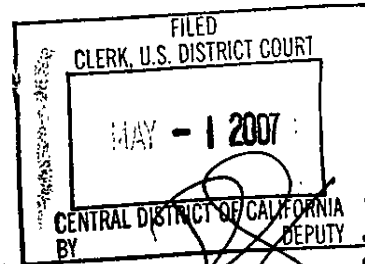

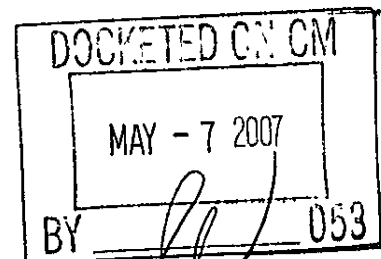

4 1. The related cases of *United States Life Ins. Co. v. Superior Natl. Ins. Co.*,
5 No. CV07-00850 VBF (JTLx) (C.D.Cal. filed Feb. 5, 2007), and *Superior Natl. Ins. Co.*
6 *v. United States Life Ins. Co.*, No. CV07-01458 VBF (JTLx) (C.D.Cal. filed March 5,
7 2007), shall be and are hereby consolidated for all purposes, including hearing on pending
8 petitions to confirm or vacate any arbitration award, motions, requests, and applications
9 (including all supporting and opposing papers); and the Court's final judgment; and

11 2. The SNICIL Insurers' Petition to Confirm Final Arbitration Award and
12 US Life's Cross-Motion to Vacate Final Award filed in *Superior Natl. Ins. Co. v. United*
13 *States Life Ins. Co.*, *supra*, and US Life's Petition to Vacate Arbitration Awards filed in
14 *United States Life Ins. Co. v. Superior Natl. Ins. Co.*, *supra*, including all papers filed in
15 support of or in opposition to said petitions and cross-motion, shall be heard concurrently
16 on June 18, 2007 at 1:30 p.m. by this Court.
