

Plaintiff and Counterclaim Defendant Roger A. Sevigny, the Commissioner of

A/S, now named Tryg Forsikring A/S ("Tryg") by and through their undersigned counsel, do hereby stipulate and agree that:

1. Pursuant to New York Ins. Law § 1213, Tryg will post security with the Court in the amount agreed between Home and Tryg of \$259,886.13;
2. The bond shall be filed not later than February 10, 2017, except that if it cannot be filed by that date for any reason, then counsel for Tryg shall so advise counsel for Home as much in advance of that date as possible and counsel shall jointly report to the Court by letter the delay and the parties' joint or respective proposals to address the same; and
3. The agreement of the parties to this Stipulation to the amount of security to be posted is not intended by either party to evidence a position or a waiver of any rights regarding the merits of this action, the amount of any possible judgment, the calculation of prejudgment interest or any other issue.




